



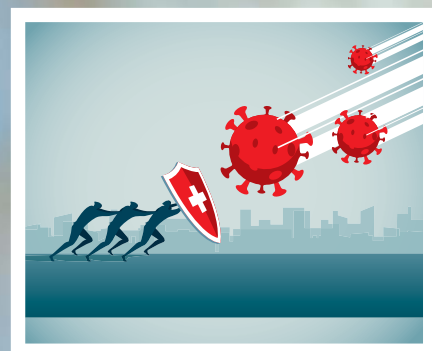

## Fumigation services

Also, fumigation can be applied on infested materials or commodities without causing any kind of disturbance in the order. ### How pests prey on stored commodities?

Different types of insects can inflict damage on stored products in several ways. The grain kernel is an easy target for pests since they either hollow it or ruin the grain as such. Insects at several stage of growth can wreck on wooden structures used for packaging or moulding. An insect activity, even in the form of excretions or cast skins, produces heat and moisture which tells upon the germination.

## PH3/Phosphine Gas Fumigation

The most preferred fumigants in this process are Aluminum Phosphide and Magnesium Phosphide owing to the fact that the residual action is nil. Phosphide fumigants can be applied in various forms like tablets, pellets or granules. They can be curatively used to treat a wide range of commodities including animal feed, food ingredients, and various types of corn, maize, wheat, rice, dry fruits, tobacco, and oats and so on. These fumigants can also be applied on processed food provided the residue doesn't contact the commodity.

Due to intensively toxic nature of fumigants, having trained experts on board is a must while executing any kind of fumigation process. Armour houses a team of professionals with a track record of carrying out such assignments for several companies in the Middle East and world over.

## Container Fumigation

Fumigation is of utmost pertinence while ship cargo gets transported between countries and the duration lasts more than 5 days. Fumigation of shipping containers is a highly recommended measure to prevent attacks from various kinds of pests like beetles, moths, weevils etc. During the onset phase, the phosphine concentrate is high and hence the personnel who discharge the cargo are warned against it. Usage of appropriate PPE during discharge is recommended.

## Tarpaulin Fumigation

## Silo Fumigation

Phosphine is used as per label directions in sealed grain bin. The fumigant used is extremely toxic to invading insects and pests. The phosphine gas is held in a sealed farm silo long enough to eliminate the target. Typically phosphine treatment lasts for 7-10 days under fumigation. This is followed by ventilation for 2-5 days with two more days for holding. The measure for the gas is determined by the volume of the storage structure. Factors like temperature will affect fumigation length. For transporting, it requires that fumigated grains are vented.

## Ship hold Fumigation

# ISPM - 15 Certification

International Standards for Phytosanitary Measures No. 15 (ISPM 15) is developed by International Plant Protection Convention (IPPC). ISPM decrees that wood materials (of thickness greater than 6 mm) used to transport ship products between countries have to be treated to avoid the spread of disease carries, insects and pests which adversely affect plants or eco-systems. Wood from living or dead trees has every chance to be infested by pests. Wood Packaging Materials (WPM) are usually made of raw wood and might not have undergone processing or treatment to remove or eliminate the pests. ISPM 15 is applicable on all wood packaging materials and requires that they be debarked, heat treated or fumigated and stamped with a mark of compliance known as 'wheat stamp'. Products exempt from ISPM 15 include packaging materials made of plastic, paper or wood panel products. ISPM 15 applies to coniferous softwood and non-coniferous hardwood used as raw wood packaging material.

The standard does not apply to wood packaging made wholly of manufactured wood-based products such as plywood and veneer, reconstituted wood products (particle board, chipboard, press wood, oriented strand board, high density fiber board, and medium density fiber board) or products created using glue, heat and pressure or a combination thereof. IPPC, RESY, European Union and several other organizations and countries have stringent regulations regarding wood or wood products crossing the border. These restrictions apply on pallets and wooden components.

## Heat Treatment versus Fumigation

### Why we promote Heat Treatment?

Heat treatment is the most preferred method for two reasons. Firstly, the US EPA strongly advocates the use of chemical methyl bromide should be phased out due to its extreme toxicity and adverse effects on ozone. Secondly using this chemical tags along a heavy legal liability for the company, the shipper, the pest control provider as well as the manufacturer. Not just that. There's an intolerable health risks for employees, other people who are involved in shipping, loading and unloading operations since contacting this chemical has irrecoverable health hazards. Heat treatment is safe and effective and the best bet is that there are no legal implications. Hence your shipment would not be delayed at international ports due to ISPM concerns.

**AE** - Indicates a two letter country code.

**054** - Indicates treatment provider's license number.

The number of letters or digits may vary according to each country.

**HT** - Indicates that Heat Treatment has taken place. The country code and treatment agent or manufacturer code must be separated by a hyphen.



## Spot the danger before it spreads

Any of these following signs would mean that termites have established their colony. Hollow-sounding wooden surfaces. A swarm of winged insects in your premises or from the soil around it. Any wall in your premises with a mural of mud tubes on exterior walls, or wooden beams.

Termite infestation is difficult to detect. Termites may live well below the ground closer to the foundation of your building. They almost always attack in huge battalions. ### Pre-construction anti-Termite Treatment

Termite Control is the first step to take if you are planning to build a house or commercial building. ARMOUR uses highly advanced techniques for treating the termite infestation.

Creating a treated zone before the construction even begins, safeguards the building from future termite infestations. A direct injection of liquid pesticide is applied to eradicate termites completely from your premises.

### The different stages of our treatment include:

Chemically treating the sides and bottom surface of the foundation. Trenches and pits are treated with chemicals to an appropriate height. Sides of all built-up walls that are in direct contact with the foundation are also treated with chemicals.

The chemicals are directed towards the masonry surfaces so that earth in contact with these surfaces is well treated. Before laying the floor, the top surface is also treated with chemicals. We also advise builders to take appropriate care during construction to avoid creating untreated gaps later.

### Post construction anti termite treatment

Post construction anti termite treatment includes identifying potential sources and zones of termite infestation like hollow wood, mud tubes, bubbling paints, frass droppings and resorting to remedial measures.

#### Walls

Holes on the walls are drilled and termiticide solution gets injected which act as check points against termite attack. Top floors are also given similar treatment if the threat is spotted.

#### Wood

Wooden fixtures in spaces also get injected with termiticide solutions. This applies for window-frames, door frames, sills, wooden bordering and other furniture in your premises. An oil based spray is used to terminate the infestation and surrounding areas are also given preventive treatment.

#### Termite tubes

Termite tubes, if spotted will be sprayed and removed and the infested area will be treated.

#### Surrounding foundation

Holes are drilled as close as possible to the plinth walls and termiticides are injected in a way that they come to contact with the soil.



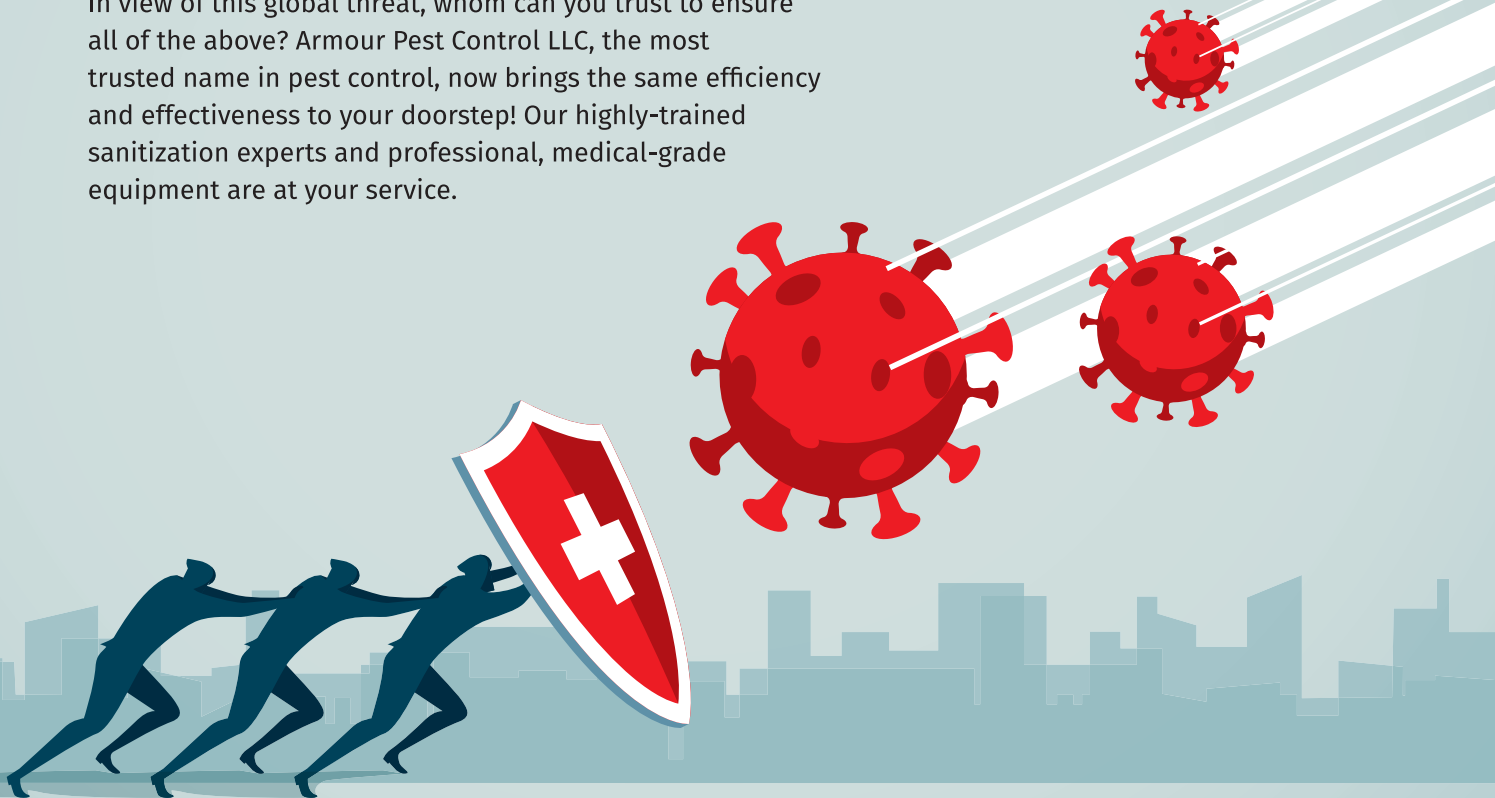
